

# SAFE SHOWING & VIEWING AGREEMENT

(AUGUST 2020)

**Agents are asked to review this Agreement with clients and related parties, and to secure signatures to acknowledge safe showing and viewing practices. Return to Listing Agent.**

This Agreement applies to ALL parties seeking access to the Property identified herein for an in-person open house, showing, home inspection, appraisal or other visit to the Property at the address of:

**39 BIG ROCK TRAIL, WESTFORD, MA 01886 - SUMMER VILLAGE AT THE POND**

ALL parties agree that they enter and view the Property at their own risk and hold each other harmless from any subsequent health and safety concerns.

BEFORE scheduling an appointment or otherwise requesting access to the Property:

- Plan on only one Buyer Agent and the Buyers/**2 adults only** in attendance (no extended family, children or friends.) For purposes of a home inspection, the Home Inspector may be present.
- Each individual must **bring their own mask** to wear. If shoe covers are not available, shoes must be removed. Use gloves when available, or use hand sanitizer.
- Submit a copy of this signed agreement to the Listing Agent prior to entering Property.
- Buyers **MUST** review MLS listing, all listing materials, including photographs, disclosures, videos, and any 3D tours. Buyers are encouraged to drive-by the Property.

PRIOR to a showing or another visit to the Property:

- Cancel or reschedule showing or another visit if any party experiences one of the following conditions or situations: fever, cough, difficulty breathing or shortness of breath, contact with anyone who has a confirmed case of COVID-19, traveled outside of the **State of Massachusetts** within the past 14 days, or have tested positive for COVID-19.
- Ensure that everyone has **mask**, and is prepared to remove shoes if shoe covers are not available.

DURING a showing or another visit to the Property:

- When possible, leave personal items (i.e., purses, backpacks, etc.) outside the Property.
- Put on clean shoe covers or remove shoes.
- Wear mask over nose and mouth.
- Use hand sanitizer provided at the property upon entering, and upon departure.
- Abide by social distancing guidelines, i.e., at least 6 feet apart.
- Avoid touching counters, tables, door knobs, personal property, etc.
- Do not sit or jump on furnishings.
- Leave doors, cabinets and lights as they were found upon entering.
- Stay within **showing time frame**, and wait for others who may still be in the Property to avoid contact.
- **Remove and dispose of any used disposable personal protective items (i.e., gloves, shoe covers) outside of the property upon departure.**

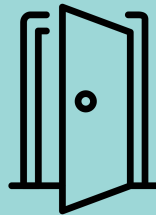

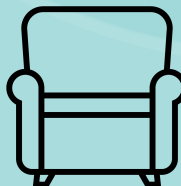
