Reference is hereby made to a certain Master Deed dated April 4, 1997 and recorded April 22, 1997 with the Middlesex South District Registry of Deeds in Book 27227, page 3, as thereafter amended (the "Master Deed") establishing the Bellows Farm Condominium (the "Condominium"), a residential condominium community located in the Town of Acton, Massachusetts.

Reference is further made to a certain Amendment to the Master Deed recorded with said Deeds in Book 32504, page 423 (the "Final Phasing Amendment"), whereby the Declarant of the Condominium established and phased in the last of the 117 Units in the Condominium.

WHEREAS, the Condominium, pursuant to the Master Deed and the various subsequent amendments thereto (including the Final Phasing Amendment), now consists of 117 residential condominium units (the "Units"), each of which has an appurtenant percentage interest in the common areas and facilities of the Condominium as set forth by the Declarant in Exhibit C to the Final Phasing Amendment; and

WHEREAS, notwithstanding the appurtenant Percentage Interests recited in the Final Phasing Amendment, the undersigned Condominium Trustees and Condominium Unit Owners (the "Unit Owners") have expressly agreed and consented to a modification of the Percentage Interests, as set forth hereinafter below, in accordance with the terms and provisions of Massachusetts General Laws Chapter 183A, Section 5(b)(1) and the Master Deed, in the belief that all Units and Unit Owners benefit equally from the Condominium's common areas and facilities, and accordingly the Percentage Interests of each of the Units should likewise be equal.

NOW, THEREFORE, in consideration of the foregoing, the undersigned Condominium Trustees and Unit Owners hereby amend the Master Deed, such that the Percentage Interests appurtenant to the various Units in the Condominium shall be equal (i.e., .8547% per Unit, as rounded off).

The undersigned Condominium Trustees further hereby certify, to the best of their knowledge and belief, that (a) the first Unit Owner signature on this Amendment was obtained, as set forth below, on June 22, 2009; (b) this Amendment has been adopted in conformity with the provisions of the Master Deed, as well as M.G.L. Chapter 183A; and (c) the party or parties executing this Amendment below as Unit Owner(s) is/are either all of the owner(s) of each of the Unit(s) or the authorized signatory or signatories, designated as such either by the Unit Owners or the Trustees, pursuant to the terms and provisions of Section 4.2 of the Declaration of Condominium Trust recorded with said Deeds in Book 27227, page 56.

The undersigned Unit Owners further hereby ratify any past use of the Percentage Interests set forth above with respect to voting computations, budget allocations, computation of common area charges, and other matters relating to the administration of the Condominium and its affairs.



AMENDMENT TO MASTER DEED

Reference is hereby made to a certain Master Deed dated April 4, 1997 and recorded April 22, 1997 with the Middlesex South District Registry of Deeds in Book 27227, page 3, as thereafter amended (the "Master Deed") establishing the Bellows Farm Condominium (the "Condominium"), a residential condominium community located in the Town of Acton, Massachusetts.

Reference is further made to a certain Amendment to the Master Deed recorded with said Deeds in Book 32504, page 423 (the "Final Phasing Amendment"), whereby the Declarant of the Condominium established and phased in the last of the 117 Units in the Condominium.

WHEREAS, the Condominium, pursuant to the Master Deed and the various subsequent amendments thereto (including the Final Phasing Amendment), now consists of 117 residential condominium units (the "Units"), each of which has an appurtenant percentage interest in the common areas and facilities of the Condominium as set forth by the Declarant in Exhibit C to the Final Phasing Amendment; and

WHEREAS, notwithstanding the appurtenant Percentage Interests recited in the Final Phasing Amendment, the undersigned Condominium Trustees and Condominium Unit Owners (the "Unit Owners") have expressly agreed and consented to a modification of the Percentage Interests, as set forth hereinafter below, in accordance with the terms and provisions of Massachusetts General Laws Chapter 183A, Section 5(b)(1) and the Master Deed, in the belief that all Units and Unit Owners benefit equally from the Condominium's common areas and facilities, and accordingly the Percentage Interests of each of the Units should likewise be equal.

NOW, THEREFORE, in consideration of the foregoing, the undersigned Condominium Trustees and Unit Owners hereby amend the Master Deed, such that the Percentage Interests appurtenant to the various Units in the Condominium shall be equal (i.e., .8547% per Unit, as rounded off).

The undersigned Condominium Trustees further hereby certify, to the best of their knowledge and belief, that (a) the first Unit Owner signature on this Amendment was obtained, as set forth below, on Nov 25, 2009; (b) this Amendment has been adopted in conformity with the provisions of the Master Deed, as well as M.G.L. Chapter 183A; (c) the party or parties executing this Amendment below as Unit Owner(s) is/are either all of the owner(s) of each of the Unit(s) or the authorized signatory or signatories, designated as such either by the Unit Owners or the Trustees, pursuant to the terms and provisions of Section 4.2 of the Declaration of Condominium Trust recorded with said Deeds in Book 27227, page 56; and (d) to the extent that the consent of certain First Mortgagees of Units is required for this Amendment pursuant to Section 20 of the Master Deed, at least two-thirds of such First Mortgagees have so consented or are deemed to have so consented, as provided in said Section 20

The undersigned Unit Owners further hereby ratify any past use of the Percentage Interests set forth above with respect to voting computations, budget allocations, computation of common area charges, and other matters relating to the administration of the Condominium and its affairs.
